WATER/SEWER TAP APPLICATION

Instructions to applicants:

Attention Developers: Development taps and/or any water/wastewater infrastructure installation(s) shall not be performed by the applicant unless Engineering has approved stamped designs provided by the customer and a Construction Inspector or a Utilities Supervisor is present. Please contact Construction Management to schedule time with the City's representative to be on-site when tap installation occurs or construction begins.

1. Applicants are required to purchase a sewer tap with the purchase of a water tap.
2. If you wish to request a waiver for the purchase of a sewer tap, you will need to provide proof of an existing septic sewer system
3. Water taps over 2 inches and sewer taps over 6 inches are not included in this application and will require a separate cost analysis which will be provided to the customer separately. In some cases, these will require a contractor to install.
4. No 1" split service will be provided.
5. The minimum size a water tap shall be 1", and the minimum size meter shall be 5/8".
6. A separate Plumbing Permit must be issued to a City registered plumber or irrigator to connect to tap.
7. The City's responsibility for tap installation is from the city main to the property line. Connection to tap from house is the responsibility of the property owner.
8. Tap cards will not be processed until application has been reviewed and approved for accuracy and payment made in full by applicant.
9. The taps fees associated with this application only covers the first 100 feet of pipe. Anything over 100 feet will be charged to the applicant for time and material cost.
10. Installation of Sanitary Sewer Clean Out is mandatory.
11. Applicant utilizing a contractor to install the tap must furnish proof of debris hauler with application (list of approved haulers can be found on the City's website).
12. For new addresses West of 103rd Street, the applicant needs to provide a copy of Centerpoint Energy Address Verification Letter along with their application: Centerpoint Energy contact information: (713) 207-4460.

Once the work order has been created, the normal time for tap installation is up to 10 weeks.

This time frame may be extended due to weather conditions, equipment failure, or number of applications in system.

Tap application process:

1. City will review the application for accuracy and contact applicant for any clarification needed.
2. Application and initial payment is received by the Municipal Utilities Department.
3. A service request is issued and applicant will receive an e-mail notice with a tracking number. Please keep this for your records.
4. Approved application will be forwarded to the Customer Service Division for tap card issuance.
5. Once tap card has been received by the Municipal Utilities Division, a work order will be created and Installation is then in que for completion.
The 10 week installation process begins once the work order has been created.
6. Once tap(s) have been installed, applicant will receive notice, via e-mail, of service request being completed and closed. Once completed you will begin receiving a water/sewer bill.
